Entry Fees

Obedience is by pre-entry only. Entries open Wednesday, February 21, 2007 and must be received on or before Saturday, April 7, 2007

Obedience entries will be limited to the first 30 received, even if the closing date has not been reached.
Obedience classes: \$15

Conformation classes: Pre-entry must be received on or before Saturday, April 7, 2007

PRE-ENTRY: Junior showmanship \$3 Non-regular \$10 Regular \$12

DAY OF SHOW: Junior showmanship \$3 Non-regular \$12 Regular \$15

Note: Altered conformation classes have the same fee schedule as regular classes

Saturday: Obedience judging begins at 8:00 AM starting with Open B. Afternoon show will begin at 1:00 PM or 1/2 hour after conclusion of AM show

Sunday: 1st Conformation show judging begins at 9 AM; 2nd Show at 1:00 PM or 1/2 an hour after conclusion of AM show

Class Order (Both days): Junior Showmanship, Non-regular puppies, Altered classes, Regular

MISCELLANEOUS INFORMATION

Obedience registration is by pre-entry only. Entries must be received no later than April 7, 2007. After the closing date, all obedience entrants will receive notification of the approximate time their class will begin. If you wish to be notified by e-mail, please put your address on your entry form.

All obedience dogs competing must have an ASCA registration number: or an ASCA Tracking Number and owners must be ASCA Service Members. All entries must be filled out on an official ASCA entry form . ASCA entry form and ASCA Tracking Number application can be obtained from the ASCA website - <http://www.ASCA.org/forms>

All OPEN obedience entrants must have completed NOVICE with ASCA. Novice titled dogs in other registries must compete in ASCA Novice. Other registry titles cannot be accepted. These are obedience TRIALS – no corrections, please! Sits and downs will be held after individual exercises. All classes held indoors on matting.

Please arrive early to pick up your armbands. The same armbands will be used both days.

There will be no food vendor on site, but lunch orders will be taken and delivered. Many restaurants are nearby.

Space and Parking is limited, please bring stackable crates! Thank you!

Directions

From the North: Take 87S to Exit 2E, go left onto Central Avenue. About 1.4 miles turnright onto Kraft Avenue (just past CITGO station. Go 1 block, Good Dog Training Center is the brown one story building directly ahead.

From I-90W: Take Exit 2/Fuller Road. Turn right at the light onto Fuller Road. At the next light turn right onto Railroad Avenue. Go 0.9 miles and turn left onto Maplewood Avenue, take immediate right onto Kraft Avenue. Good Dog Training Center is the brown one story building directly ahead.

From I-90E: Take Exit 2/Washington Avenue. Bear right onto Washington Ave. At light, turn right onto Fuller Road. Go to your second traffic light and turn right onto Railroad Ave. Go 0.9 miles and turn left onto Maplewood Avenue, take immediate right onto Kraft Avenue. Good Dog Training Center is the brown one story building directly ahead.
