## NOTICE TO EXHIBITORS

- This trial will be held according to ASCA Agility regulations. Exhibitors, through submission of their entry, acknowledge that they are knowledgeable of ASCA rules and regulations, and agree to abide by all rules in effect at the time of this trial. The ASCA Agility Rulebook is available at: [www.asca.org](http://www.asca.org)
- ASCA, STASC and Max 200 will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause.
- All dogs must be on a leash when not competing in the ring or at the practice jump/warm up area.
- Any exhibitor whose dogs and/or children create any unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee be asked to leave the show site. In such a case, no refunds will be made.
- Entries from individuals who are not in good standing with ASCA will not be accepted.

## EQUIPMENT:

Slatless dogwalk and teeter, Slatted A-frame will be used. Jumps, including double, tunnels, chutes and non-displaceable tire may be used at the judge's discretion. The A-frame shall be set at 5'6".

**Electronic timing will be used at this event.**

## PRIZES AND AWARDS:

Qualifying and 1<sup>st</sup> through 4<sup>th</sup> place ribbons will be awarded in each class. Placements will be combined for 20+ and 24" dogs in all divisions. A rosette will be awarded for new titles and ATCH.

## REFUNDS

There will be no refund for entries withdrawn after the closing date, except for a dog's injury and/or illness or for bitches that come into season after the closing date. These entries will be eligible for a refund of the amount of the total entry fee less \$15. A signed letter from your veterinarian must be included with your written request. Requests must be received by the trial secretary prior to the start of the trial. There shall be no refunds for entries withdrawn in the event a dog and/or handler are dismissed from competition.

## IMPORTANT INFORMATION ON ENTRIES:

- Entries postmarked before the opening date of Thursday May 1, 2008 WILL NOT BE ACCEPTED
- Pre-entries must be received by the closing date of Friday, June 27, 2008.
- Entries will be accepted by order of postmark.
- Do not mail your entries by any method that requires a signature.
- Entries cannot be accepted or canceled after the closing date.
- Entries are limited to a maximum of 350 runs per day.
- ASCA Registration/Tracking No. – If your dog is an ASCA registered Australian Shepherd or has an ASCA Tracking Number, write your dog's ASCA number on the entry form.
- If this field is left blank, the ASCA Business Office will assume this dog is not registered with ASCA and will not automatically track qualifying legs. You may submit the Tracking Form with your entry – however, please make fees payable to ASCA.
- Junior Handler entry fees will be one-half of the published fees. To be eligible for this discount, the Junior Handler must own or co-own the dog they are showing.
- 'For Exhibition Only' entries will not be accepted.
- Returned checks do not constitute a valid entry fee. Returned check will incur a \$20 service charge.
- Entries must be submitted on the forms or copies of the forms supplied in this premium.
- Please double check your entry to ensure it is filled out completely and that you have signed the release form.

## MOVE-UPS

After submitting your entry, the last day that we will be accepting move-ups for the trial will be Monday, July 7, 2008. We will accept move-ups in writing only (mail or e-mail) No changes will be accepted after this date. Day to Day move-ups will be allowed during trial in person within 30 minutes of last run on Saturday.

## FOOD VENDOR:

There will be no food vendor on site. Lunch and snacks will be provided for all workers.

## REGISTRATION / MEASURING:

- Saturday and Sunday between 7:00 AM and 7:30 AM
- Copies of either NADAC or AKC height cards may either be mailed in or presented at registration for dogs entering the Small and Medium dog Classes (dog's wither height 18" and under). Otherwise they will need to be measured at registration.

- Jump Height Metric Conversions: 4" (10cm), 8" (20cm), 12" (30cm), 16" (40cm), 20" (50cm), 24" (60cm)

- A dog may be entered in a class at a jump height higher than they are eligible provided the dog is not entered in the Junior Handler or Veteran Division classes.

- No dog shall ever jump lower than 4" in the Junior Handler or Veteran Division and no dog shall ever jump lower than 8" in the Standard Division.

- Any exhibitor whose dog measures over 20" may choose to enter the 20+ class or the optional 24" class. 20+ and 24 will be scored and placed together as one class.

- Refer to the current ASCA rulebook for the current Breed Jump Height Exemption List.

## ASCA Service Membership and Tracking Number Application

**Beginning 1/1/2003 for non-ASCA registered dogs** – In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership type of 'Service' is required). ASCA membership does not need to be maintained in subsequent years.

**It will be the responsibility of the owner to identify to ASCA the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA qualifying legs earned from 1/1/2003 until submission of application.**
