**ENTRY FEES:** TD.....\$60.00

**Entry Limitations:** There will be 6 TD tracks. Trial is open to all breeds, who must be six months of age or older. Entries must be on an official ASCA entry form and will not be accepted without fees and signature, and a statement of certification. When the limit of 6 dogs for the TD test have been drawn, all remaining entries, subject to the conditions set forth above, shall be assigned a position on the alternate list corresponding to the order in which they are drawn. The test secretary shall notify all entries of the results as soon as possible. All entries will not be accepted without proper fees. Returned checks do not constitute a valid entry. All returned checks are subject to a fee of \$35.00.

**REFUNDS:** No entry fee will be refunded after closing date, except the entry of a non-participating alternate, or, if an accepted entry cancels and the secretary is able to replace the entry from the alternate list. No entry fee will be refunded if the show cannot be opened or completed by reasons of riots, civil disturbances, fires, acts of God or public emergency.

**Test Entrants must be at the Test Site by 9:00 a.m. on March 14, 2010**, at which time there will be a drawing for tracks for each dog entered. The first track will be run as soon thereafter, as it has aged the proper length of time. In the event of absentees among the confirmed entries, the next alternate, in catalog order, who is present, will be allowed to fill the vacancy. "Bitches in season may participate", according to Chapter 2, Section 8 of ASCA tracking regulations.

Turn left onto Beale Road - there is a Campground sign before the turn, as well as signs to Lil' John's Mountain Music Park, which is held at the Campground. Follow Beale Rd, apx. one mile to an intersection, go straight across. Longest Acres Rd. will be on the left, approximately three miles from Hwy 49, with a sign marking Cane Creek Campground. Turn into the campground and we will be meeting up in the campground area at the museum building.

1. Exhibitor/Owner, whether members or not of ASCA, will abide by the rules and regulations of the Australian Shepherd Club of America, Inc., and any other rules and regulations appearing in the premium list of the event.
2. Exhibitor/Owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
3. Exhibitor/Owner acknowledge all hazards represented by the event and the event premises, including, but not limited to, the condition of the fields, floors, stairways, halls, lighting, security measures or lack thereof, show grounds, parking areas and the presence of unfamiliar animals and people; Exhibitor/Owner assume the risk of any harm arising from these.
4. Exhibitor/owner release ASCA and will defend ASCA and hold it harmless from present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises.
5. Additionally, Exhibitor/Owner hereby recognizes the inherent danger of this event and assumes the sole responsibility for and agrees to indemnify, defend and save the aforementioned parties, including but not limited to Judges, tracklayers, or other volunteers, harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by the law upon and of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and where or not the same may have been caused by or may be alleged to have been caused by the negligence of the aforementioned parties or any of their agents or any persons.

This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (minimum membership type of "Service" is required). ASCA® membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA® the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA® qualifying legs earned from 1/1/2003 until submission of application.**

**\* FREQUENTLY ASKED QUESTIONS \***

**Do I have to have a tracking number to compete?**

No, you do not need a tracking number in order to compete in Agility or Stock.

You will need a tracking number to enter an Obedience trial or Tracking Test.

Your dog does not have to be a purebred to receive a tracking number from ASCA®.

**Why would I need or want a tracking number for my dog?**

If you would like to have your dog's points and titles recorded by ASCA®, and if you'd like to receive title certificates in the mail for your accomplishments, you might want to obtain a tracking number.

**How much is the total cost for a tracking number?**

In order to obtain a tracking number for your dog, you must be at least a "Service" member. The cost for Service Membership is **\$10**.

- Your membership is good for one year; however, it does not need to be maintained in subsequent years, unless you want to obtain another tracking number for another dog after your membership has expired.

This membership fee is **in addition** to the tracking fee of **\$10** per dog. A tracking number is good for the lifetime of the dog. If you only have one dog, the total cost would be **\$20**. For two dogs, the cost would be **\$30**, for three, the cost would be **\$40**, etc.
