Open to all breeds and mixed breeds. As of Jan. 1st 2004 all dogs now must have an ASCA number or a tracking number. To obtain a tracking number go to www.asca.org or call 979-778-1082. Entrants must have completed previous level with ASCA. No refunds after closing date

.This is an ASCA sanctioned show – no food or corrections allowed. No prong or electric collars allowed on the grounds. ASCA Show rules apply. “Day of” entries, if allowed, must be presented to the Show Secretary at least one half hour before start of trial. *After the pre-entry deadline, all obedience entries will receive notification by e mail or post card, of the approximate time their classes will start. Please include your e-mail address on your entry form. Day of Show entries may require start times to be adjusted.*

If showing in both Rally and obedience, exhibitors are responsible for letting judges know of a possible conflict. Judges do not have to hold the class for an exhibitor.

Pizza supper is included in entry fees. We also encourage participants to bring a covered dish to share as well.

All dogs must be on leash at all times except when in the ring. Please have Rabies proof available.

Hotels:

Please be sure to verify that the motel accepts dogs – some have an additional fee for pets.

Remember to respect the property of your host motel indoors and out!

We are counting on you to be on your best behavior in order to maintain the working relationship with our motels and hotels. Our hard-earned reputation, as well as our ability to continue hosting trials, is certainly on the line and dependent on YOUR cooperation. - Double-check on rates & charges. Call to confirm your reservation a few days before arriving.
- Please be honest about how many people & dogs will be staying in the room.
- Of course, as is standard agility procedure, all handlers/owners will pick up after their dogs. Please bag and dispose of dog waste properly.
- Do not groom dogs in rooms.
- Keep dogs off furniture. Please cover the motel's bedding with a sheet or blanket from home, whether or not you think your dog will get on the bed.
- Be sure to report any damage which may occur.
- Do NOT leave dogs unattended.

DIRECTIONS TO TRIAL SITE

From North and South

Take I-87 (Adirondack Northway) to Exit 14. Follow signs for Schuylerville and Route 29 east. Take Route 29 east through Schuylerville, across the Hudson River and up the hill. *Right onto Route 40 South. First left onto Bulson Rd. (Elks Club on Corner) Go to end, right on Hegeman's Bridge Rd. First left onto Louse Hill Rd., High Goal Farm is 2nd drive on right.

From Western New York

Take I-90 East (NYS Thruway) to Exit 24 (Albany). Take I-87 North (Adirondack Northway) to Exit 14. Follow signs for Schuylerville and Route 29 east. Take Route 29 east through Schuylerville, across the Hudson River and up the hill. Follow from * above.

From East

Take the MASS Turnpike to NYS Thruway. Take NYS Thruway to Exit B1 (Albany). Follow I-90 to exit 7 (I-787 North). Follow I-787 North to exit 7. Follow Route 7 west to intersection of I-87 North (Adirondack Northway). Take I-87 North (Adirondack Northway) to Exit 14. Follow signs for Schuylerville and Route 29 east. Take Route 29 east through Schuylerville, across the Hudson River and up the hill. Follow from * above
