

## ABOUT THE SEMINAR

Gary Shipley is teaching an all-day elite-level agility handling seminar on Friday, June 8, 2018, before the Colors of Summer trial. The overall topic of the seminar will be Handling for Speed (focusing primarily on handling ASCA type courses), and will teach and practice walking the course, placement and timing of side changes (front, rear, blind crosses), handler body cues (intentional and non-intentional) and how those cues relate to an efficient path for the dog, handler and dog connection, etc. The skills covered can be applied in both close as well as distance handling. If time permits we may also cover some basic gamble techniques for performing Elite level ASCA gambles. We can accommodate 10 **elite/masters** - level working teams (dog + handler) to give ample running time, and unlimited auditors (any level). Entries are open to all breeds and will be taken first come, first serve by postmark, no earlier than Feb 15<sup>th</sup>, 2018. If available, entries will be taken up to the start of the seminar. There will be a waiting list in case there are cancelled entry slots available. Those checks will be shredded if there are no slots available.

## AGREEMENT

The patron who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both handler and the owner of entered dog. In consideration of acceptance of this entry:

Handler/owner entering onto the Westfield Fairgrounds is responsible to keep their dog(s) contained and under control outside the ring at all times while on grounds. All poop generated must be picked up promptly and discarded in receptacles provided.

Handler/owner certifies that the participating dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

Handler/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to, the condition of the grounds, floors, stairways, lighting, security measures or lack of, electrical appliances, fitting, agility ring, parking areas, and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

Handler/owner releases the Westfield Fair Association, ASCNE and Gary Shipley, and will hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, event, or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for, and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this seminar, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
