Rally Classes - Classes: Masters, Excellent, Advanced, Novice, Levels: A,B,C

– Limit to 25 Entries per trial, starting with Masters

AM Trial - Entries taken 7:30-8:00, Trial starts at 8:30,

PM Trial - Entries taken 10:00-10:30. Trial starts at 11:00 or 1/2 hour after the AM trial ends, if it runs later than 10:30 AM

Obedience

Regular Obedience – Utility, Open, (ODX/CDX) Novice - levels A,B, Veterans can jump 4" lower
Optional Titling Class: Beginner Novice levels A,B, Graduate Novice, Versatility. Trials will start with Utility
Saturday Trial 3 Limit to 20 Entries, ~ Open, Novice, and Beginner Novice only

Sunday Trials Limit to 25 Entries, per trial ~ All Classes, starting with Utility

Saturday trial 3 – Entries taken 12:30-1:00. Trial starts at 1:30 or 1/2 hour after the AM trial ends, if it runs later than 1:00 PM

Sunday AM Trial - Entries taken 7:30 - 8:00. Trial starts at 8:30

Sunday PM Trial - Entries taken 10:00-10:30. Trial starts at 11:30 or 1/2 hour after the AM trial ends, if it runs later than 11:00 AM

Sits and Downs will be held After individual exercises.

This is an ASCA sanctioned show, no food or corrections allowed.

Fees

Pre-entries Open 5/24/21 and close on 07/26/2021, or when limits have been met.

Pre-entry: \$24 for Regular and Optional Titling

ASCA Information

- **All Dogs must have proof of registration and rabies certificate available.**
- All dogs must have an individual ASCA registration or LEP number or an ASCA tracking number to compete in ASCA sanctioned Obedience and Rally Trials
- For information regarding what Obedience classes you may enter, refer to the Obedience and Rally rules on the ASCA site: <https://www.asca.org/competitive-programs/>
- All dogs competing for ASCA Obedience or Rally titles are required to start at Novice; regardless of titles awarded by other Registries.
- ASCA Obedience judges may not enter or handle in the A classes.
- No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

Registration & Tracking

- All Australian Shepherds over the age of 6 months must be registered.
- Effective January 1, 2004: All dogs six (6) months and older must have an individual ASCA registration or LEP number or and ASCA tracking number to compete in ASCA sanctioned Obedience Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience Trials.
