**This show will be held under the current rules and regulations of ASCA.**

No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs: or a person not in good standing with ASCA.

**Jr. Handling:** Pee-Wee 3-5, Sub Jr 6-7, 8-12 Novice, 8-12 Open, 13-17 Novice, 13-17 Open, BJH

**Non-Regular Classes** (Divided by Sex): 2-4 Month Puppy, 4-6 Puppy, BOB Puppy

**Regular Altered & Intact** (Divided by Sex): 6-9, 9-12, 12-15, 15-18, Novice, Am. Bred, Bred-By, Open (Divided by Color), Winners Dog, Winners Bitch, Best of Breed

**Awards:** Ribbons 1<sup>st</sup> – 4<sup>th</sup> Place, Rosettes, awards all shows.

**Facility Accommodations:** The show will be held outdoors on grass (no electricity available). The grounds will open at 7:30 AM for setup. Ringside seating is ok, but if you did not travel together please remain 6' apart. Please provide your own shade, water and seating. Grooming set ups will be from your vehicle on grass.
