Judging: Trial1: Debra St. Jacques, NY
Trial 2: Rachael Brostrom, MA
Trial 3: Janet Kelly, SC

RALLY Classes offered: Starting with Masters: Masters, Excellent, Advanced, Novice
Levels A, B, C Limited to 30 Entries per trial

First trial starts 9 AM

Second trial starts at 11 AM or ½ hour after the first Rally trial ends, if it runs later than 11

Third trial starts at 1 PM or ½ hour after the second Rally trials ends, if it runs later than 1

***A 30 minute lunch break may be taken at the discretion of the Judge

Building opens at 7:30 a.m. and closes ½ hour after Trial 3 ends

Pre-entries: Open 2/24/23, close 4/21/23, or when limits have been met

If limits are met "day-of" entries will not be accepted and a wait list will be kept.

No refunds after pre-entry closing date

Pre-entry Special – For the same dog: \$23 for 1 entry, \$66 for 3 entries, \$126 for 6 entries

Day of Show entries: (if limits have not been met) \$25 per entry for Rally. Trial 1 entries taken 8-8:30am, Trial 2 entries taken from 8-10:30 and Trial 3 entries taken 8:00am – 12:30 PM

This will be held inside on matting. Ribbons are awarded for qualifying and placement.

This is an ASCA sanctioned show, no food or corrections allowed.

Bitches in Season are not allowed to compete. No flexi leads on property

The trial will be held according to ASCA and Massachusetts State Law COVID guidelines on that day. Please make sure you are aware of all guidelines in effect. Checks will be shredded if the trial is canceled.

These trials will be held under the current rules & regulations of ASCA. No entries will be accepted from a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA.

Effective January 1, 2004: All dogs six (6) months and older must have an individual ASCA registration or LEP number or and ASCA tracking number to compete in ASCA sanctioned Rally Trials. Rabies certificates must be available. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Rally Trials.

- The Novice A classes are for a handler who has not placed an Obedience or Rally title on a dog from ASCA or any other registry and the dog does not have an Obedience or Rally title from any registry
- All dogs competing for ASCA titles are required to start at Novice level and work through Masters regardless of titles awarded by other registries

Directions to Collinswood K-9:

From the EAST on Massachusetts Turnpike—I-90: Take exit 90 for MA-12 toward I-395/I-290/ /Auburn/Worcester for .7 miles. Then keep right following signs for MA-12 S/US-20 W/Charlton for .2 miles. Merge onto MA-12 S. Pass Friendly's on the left after .2 mile continue another .4 miles. Turn right onto West St and go .6 miles. Collinswood K-9 will be on your left.

From the WEST on Massachusetts Turnpike-I-90: Use the right two lanes to take exit 90 for MA-12 toward I-395 S/I-290 E/Worcester/New London Connecticut for .4 miles. Then keep right following signs for MA-12/US-20 W/Charlton for .2 miles. Merge onto MA-12 S. Pass Friendly's on the left after .2 mile and continue another .4 miles. Turn right onto West St. and go .6 miles. Collinswood K-9 will be on your left.
