**First Trial starts 9:30 AM**

**Second Trial starts at 12 PM** or ½ hour after the first Rally trial ends, if it runs later than 12PM

**Third Trial starts 2PM** or ½ hour after the second Rally trial ends, if it runs later than 2PM

Lunch will be taken at the judge's discretion

**Pre-entries:** Open 02/14/24, close 04/14/24, or when limits have been met

Entry by Postmark Date (not delivery date) No refunds after closing date  
If limits are met "day-of" entries will not be accepted and a wait list will be maintained

*Pre-entry Special – For the same dog: 1 entry=\$28, 2=\$50, 3=\$72, 4=\$93 5=\$114, 6=\$132*

**Day of Show entries:** (if limits have not been met) \$30 for 1 entry, 55 for 2 entries and \$28 for each additional entry in Rally

**Entries Taken:** First Trial—8:00 to 9:00 am, Second Trial—8:00-11:30am, Third Trial-8:00-1:30

**The trial will be held according to COVID guidelines on that day. Checks will be shredded if the trial is canceled.**

These trials will be held under the current rules & regulations of ASCA. No entries will be accepted from a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA. All Australian Shepherds over the age of 6 months must be registered. All dogs must have individual ASCA registration and rabies certificate available.  
Effective January 1, 2004: All dogs six (6) months and older must have an individual ASCA registration or LEP number or and ASCA tracking number to compete in ASCA sanctioned Rally Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Rally Trials. #### **Directions to Collinswood K9**

**From the East on Massachusetts Turnpike-I-90:** Take exit 90 for MA-12 toward I-395/I-290 Auburn/Worcester for .7 miles. Then keep right following signs for MA-12 S/US-20 W.Charlton for .2 miles. Merge onto MA-12S. Pass Friendly's on left after .2 miles continue another .4 miles. Right onto West St. and go .6 miles. Collinswood K9 will be on your left.

**From the West on Massachusetts Turnpike—I-90:** Use the right two lanes to take exit 90 for MA-12 toward I -395 S/I-290, E. Worcester/New London, Conn for .4 miles Then keep right following signs for MA-12/US-20 W. Charlton for .2 miles. Merge onto MA-12S. Pass Friendly's on left after .2 miles continue another .4 miles. Right onto West St. and go .6 miles. Collinswood K9 will be on your left.
