A food truck will be on site from approximately 7:30 AM to 2 PM

The trial will be held according to COVID guidelines on that day. Checks will be shredded if the trial is canceled.

These trials will be held under the current rules & regulations of ASCA. No entries will be accepted from a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA. All Australian Shepherds over the age of 6 months must be registered. All dogs must have individual ASCA registration and rabies certificate available.

Effective January 1, 2004: All dogs six (6) months and older must have an individual ASCA registration or LEP number or and ASCA tracking number to compete in ASCA sanctioned Obedience Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience Trials. BIS are not allowed for Rally trials

BIS will be allowed for Obedience with the following restrictions:

- Handlers must notify the Show/Trial Secretary at least thirty minutes before the start of the trial if they plan to compete with a bitch in season.
- BIS must be crated (not placed in an exercise pen) at least 50 feet away from the obedience rings
- BIS must always wear pants in or within 50 feet of any obedience rings
- When it is time for BIS to compete, the team(s) will be allowed to warm up in proximity to the obedience ring(s) for a reasonable amount of time.
- BIS will compete, after all run offs and awards are completed, for legs and scores only.

Directions to Westfield Fairgrounds:

From Interstate 91: Take Exit 12 (old exit 15), Holyoke Mall at Ingleside. Turn left at bottom of ramp. Go to second set of lights and turn right onto Homestead Ave. At next light turn left onto Rt. 202. Go approximately 5 miles. Cross Rt. 10 (at light) and go to cemetery on the left. At stop sign turn left. Show site is on the left, about 1 1/2 miles.

From the Massachusetts Turnpike—I-90: Take exit 41 (old exit 3). Turn right at the light at the end of the ramp. Go about 100 ft. and make a right onto Arch Road. (Westfield Motor Inn/Westfield Econo Lodge is on the corner.) Go about 1.5 miles. the Southern States Building on your right, make a left onto Cabot Road. Go to the end of Cabot and make a right onto Russellville Rd. Show site is a short distance up on the right.
